SCHOOL BOARD 101



WHAT IS A SCHOOL BOARD?

School Boards in Colorado are composed of unpaid, elected representatives who are selected to represent their community in school district level decisions.

WHAT AUTHORITY DO THEY HAVE?

School board members are responsible for overseeing the management of schools and services in their school district. This means that they ensure that students get the best education for the tax dollars spent and advocate that their community's school receive proper funding. Some of the primary responsibilities of the school board is to hire the superintendent, approve the budget, and set the strategic direction of the school district.

WHO DO THEY REPRESENT?

School board members are elected representatives of the residents of the districts in which they reside.

WHAT ARE THE REQUIREMENTS TO RUN FOR SCHOOL BOARD?

Candidates must be a resident of the school district and a registered voter for at least 12 consecutive months prior to the election. No person who has been convicted of a sexual offense against a child is eligible to serve on the school board. Because school director elections are nonpartisan, candidates may not campaign as members of a political party.

HOW LONG DO THEY SERVE?

Each school board member is elected to serve a four-year term and can run for two terms.

WHEN ARE ELECTIONS HELD?

School Board elections are held in odd years. Not all representatives are up for election at the same time to provide some consistency on the board. For example, four members will be elected in November 2017 and the remaining three members are elected in November 2019.

Aurora's board seats are all "at-large," covering the entire district.

Five of the seven Denver school board seats are elected by a region of Denver, (for example District 4 covers Northeast Denver), and two seats are "at-large" meaning all district residents can vote for these representatives. One at-large representative is elected during each school board election.

WHO CAN VOTE IN SCHOOL BOARD ELECTIONS?

All registered voters in the district can vote for their school board representative regardless of whether or not they have children in the public school system.
